ASSIGNMENT

AND WE HEREBY grant to James J. DeCarlo, Albert L. Jacobs, Jr., Gerard Diebner, Joseph M. Manak, Adam B. Landa, Paul J. Sutton, Barry J. Schindler, and Michael A. Nicodema, attorneys with the firm of Greenberg Traurig LLP, the right and full power of attorney to enter all further identifying information of the improvements and the application as may be deemed necessary or desirable for the recordation or perfection of this **ASSIGNMENT**.

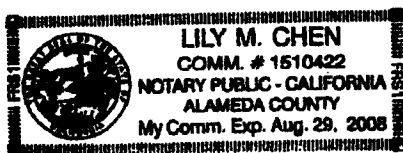
