ASSIGNMENT



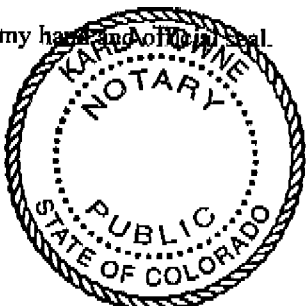


