**RESTATED ARTICLES OF INCORPORATION  
OF  
PRIO CORPORATION**

**ARTICLE 1**

**NAME**

The name of the corporation is PRIO Corporation (the "Company").

**ARTICLE 2**

**PURPOSES AND POWERS**

The purposes for which the Company is organized are to engage in any lawful business, trade or activity for which a corporation may be organized under the Oregon Business Corporation Act, and the Company shall have the same powers as an individual to do all things necessary or convenient to carry out its business and affairs, including, but not limited to, the powers specified in the Oregon Business Corporation Act or which may be hereafter granted by such law.

**ARTICLE 3**

**AUTHORIZED CAPITAL SHARES**

The total number of shares which the Company shall have authority to issue is 1,000 shares.

**ARTICLE 4**

**NO PREEMPTIVE RIGHTS**

Except as may be otherwise provided by the Board of Directors, no holder of any shares of the Company shall be



(a) The Company would not be able to pay its debts as they become due in the usual course of business; or

(b) The Company's total assets would be less than the sum of its total liabilities.

**ARTICLE 8**

**BYLAWS**

The Board of Directors shall have the power to adopt, amend or repeal the Bylaws of the Company and to adopt new Bylaws, subject to the power of the shareholders to amend or repeal such Bylaws. The shareholders shall also have the power to amend or repeal the Bylaws of the Company and to adopt new Bylaws.
