
AND WHEREAS, at the time the invention was made, I was under an obligation to assign all of my right, title, and interest in said invention to Habasit AG.

And I hereby authorize and request the Director of U.S. Patent and Trademark Office to issue said United States Letters Patent to said Habasit AG as the assignee of the whole right, title, and interest thereto.

And I further agree to sign and properly execute such necessary and lawful papers for application for foreign patents, for filing subdivisions of said application for patent, and for obtaining any reissue or reissues of any Letters Patent which may be granted for my aforesaid invention, as the assignee thereof shall hereafter require and prepare at its own expense.
