## CONFIRMATORY PATENT APPLICATION ASSIGNMENT

This Confirmatory Patent Application Assignment Agreement, dated July 14, 2006 is made by Zarlink Semiconductor Limited, a corporation incorporated under the laws of England and Wales ("Assignor"), to Intel Corporation, a Delaware corporation ("Assignee").

### RECITALS

For good and valuable consideration, the receipt of which is hereby acknowledged, Assignor has, on October 7, 2005, pursuant to the terms of the Agreement, sold, transferred, conveyed, assigned and delivered to Assignee, with full title guarantee all of Assignor's right, title and interest in and to the Patent Applications and any patents that may issue there from, including any foreign counterparts, divisions continuations, or reissues of such patents, the same to be held by Assignee for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns and other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment and sale had not been made; together with all claims for damages by reason of past infringements of the Patent Applications, along with the right to sue for and collect such damages for the use and benefit of Assignee and its successors, assigns and other legal representatives.

2. Assignor hereby authorizes and requests the Commissioner of Patents of the United States, and, in the case of any patent applications filed with any office of any country or countries foreign to the United States, any officer of such country whose duty it is to issue patents or other evidence or forms of intellectual property protection or applications as aforesaid, to issue the same to Assignee and its successors, assigns and other legal representatives in accordance with the terms of this instrument.


