AND I request the Commissioner of Patents and Trademarks to issue any patents of the United States which may be issued for said inventions to said KRISHNA IMPORTS, INCORPORATED d/b/a STEPHENS INSTRUMENTS, its legal representatives, successors or assigns, as the sole owner of the entire right, title and interest in and to said patent and the inventions covered thereby.

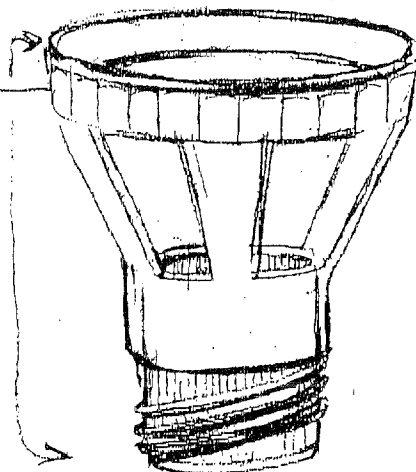

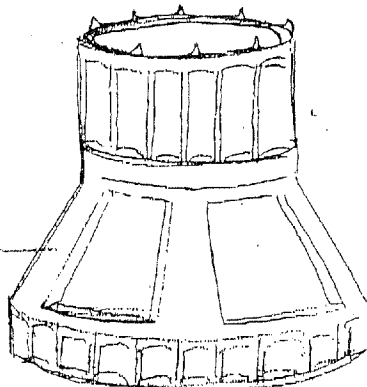


90° cross-hair
