Assignee agrees that the provisions of this patent assignment are subject and pursuant to, in all respects, the terms and conditions of the Purchase Agreement. Assignor will execute and deliver from time to time at the request of Assignee such further instruments of transfer, assignment, prosecution and further assurance as may be reasonably required in order to vest and confirm to Assignee full and complete title to Gam-Med's interest in the letters patent, patent applications, and the inventions described or shown therein, to the fullest extent the same are transferrable or assignable pursuant to said UCC sale.

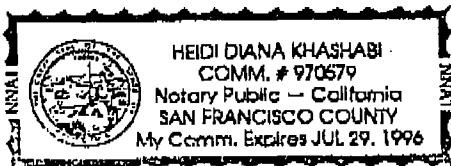
