PATENT RELEASE AND REASSIGNMENT

THIS PATENT RELEASE AND REASSIGNMENT is made as of August 10, 2006, by ANTARES CAPITAL CORPORATION, as First Lien Collateral Agent ("Antares").

WITNESSETH:

WHEREAS, Antares and Torca Products, Inc, a Michigan corporation ("Borrower"), were parties to that certain Patent Security Agreement dated as of August 27, 2004 (the "Security Agreement"; capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Security Agreement), pursuant to which Borrower granted a security interest to Antares in, among other things, the Patent (as defined in the Security Agreement) as security for certain obligations owing by Borrower to the financial institutions (collectively, the "Lenders") from time to time party to that certain Credit Agreement by and between Borrower and Antares, as amended, restated, supplemented or otherwise modified and in effect from time to time, including the Patents set forth on Exhibit A hereto; and

WHEREAS, the Security Agreement was recorded by the Patent Division of the United States Patent and Trademark Office on September 3, 2004, at Reel 015748, Frame 0325; and

WHEREAS, Borrower has requested that Antares release its security interest in the Patents and reassign the same to Borrower;

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Antares hereby releases its security interest in all of Borrower's right, title and interest in and to all of the following:

(a) all patents, registered patents, patent applications, including, without limitation, the registered patents and patent applications listed on Exhibit A attached hereto and made a part hereof, and (i) all renewals thereof, (ii) all income, royalties, damages and payments now and hereafter due and/or payable under and with respect thereto, including, without limitation, payments under all licenses entered into in connection therewith and damages and payments for past or future infringements or dilutions thereof, (iii) the right to sue for past, present and future infringements and dilutions thereof, and (iv) all of Borrower's rights corresponding thereto throughout the world (all of the foregoing registered patents and patent applications, together with the items described in clauses (i)-(iv) in this paragraph (a), are sometimes hereinafter individually and/or collectively referred to as the "Released Patents");

(b) all rights under or interests in any patent license agreements with any other party, whether Grantor is a licensee or licensor under any such license agreement, including, without limitation, those patent license agreements listed on Exhibit A attached hereto and made a part hereof, and the right to prepare for sale and sell any and all Inventory now or hereafter owned by Grantor and now or hereafter covered by such licenses; and

(c) all proceeds of the foregoing.

2. Antares hereby reassigns, grants and conveys to Borrower, without any representation, warranty, recourse or undertaking by Antares, all of Antares's right, title and interest in and to the Patents.
