ASSIGNMENT

WHEREAS, we, Robert Ian Hedley of New South Wales, Australia, and Christopher Nash Whybin of Queensland, Australia, have invented a new and useful DEVICE FOR CHANGING A VEHICULAR COMPONENT, for which an application for a United States patent entitled DEVICE FOR CHANGING A VEHICULAR COMPONENT was filed on April 17, 2006 and assigned Serial No. 11/405,828 (claiming the benefit of Australian provisional patent application no. 2005901906 (filed April 15, 2005)) preparatory to obtaining a United States patent therefor; and

Thorley Via Singleton, New South Wales 2330, Australia, is desirous of acquiring all our right, title and interest in and to said DEVICE FOR CHANGING A VEHICULAR COMPONENT, in and to said application for United States patent, and in and to any patents that may be granted for said DEVICE FOR CHANGING A VEHICULAR COMPONENT in the United States and in any and all foreign countries;

NOW, THEREFORE, in consideration of the sum of One Dollar (\$1.00) to us in hand paid, the receipt of which is hereby acknowledged, and other good and valuable consideration, we, Robert Ian Hedley and Christopher Nash Whybin, have sold, assigned and transferred, and by these presents do sell, assign and transfer unto Justoy Pty Ltd the entire right, title and interest in and to said DEVICE FOR CHANGING A VEHICULAR COMPONENT in the United States of America and its territorial possessions and in all foreign countries, the entire right, title and interest to said application for United States patent and the entire right, title and interest in and to any and all patents which may be granted for said DEVICE FOR CHANGING A VEHICULAR COMPONENT in the United States and its territorial possessions and in any and all foreign countries and in and to any and all divisions, reissues, continuations and extensions thereof.

We hereby authorize and request the Patent Office Officials in the United States and in any and all foreign countries to issue any and all of said patents, when granted, to Justoy Pty Ltd, as the assignee of our entire right, title and interest in and to the same, for the sole use and enjoyment of Justoy Pty Ltd, its successors and assigns.

FURTHER, we agree that we will communicate to Justoy Pty Ltd, or its representatives, any facts known to us respecting said DEVICE FOR CHANGING A VEHICULAR COMPONENT, that we will testify in any legal proceedings, sign all lawful papers and execute all divisional, continuation, substitution, renewal and reissue applications respecting said DEVICE FOR CHANGING A VEHICULAR COMPONENT, that we will execute all necessary assignment papers to cause any and all of said patents to be issued to Justoy Pty Ltd, and that we will make all

rightful oaths and generally do everything necessary or desirable to aid Justoy Pty Ltd, its successors and assigns in obtaining and enforcing proper protection for said DEVICE FOR CHANGING A VEHICULAR COMPONENT in the United States and in any and all foreign countries.
