

ASSIGNMENT

WHEREAS we, Slawomir Opusko, Paul A. Hughes, Michael L. Becraft and Larry B. McAllister, residing at 447 Rolling Pines Lane, Duncan, SC 29334, 202 Meeting Place, Greenville, SC 29615, 5 Avens Hill Drive, Greer, SC 29651 and 204 Julien Place, Spartanburg, SC 29301 respectively, have made an invention relating to Multilayer Film Comprising Polylactic Acid, which invention is described in an application for Letters Patent of the United States entitled MULTILAYER FILM COMPRISING POLYLACTIC ACID and filed at the United States Patent and Trademark Office on May 5, 2006 under Serial No. 11/418,583; and

McAllister, by these presents do sell, assign, and transfer to Cryovac, Inc., its successors and assigns the full, exclusive, and world-wide right to the said invention and the entire right, title, and interest in, to, and under any Letters Patent which may be granted therefor in the United States, in the territorial possessions of the United States, and in any country foreign to the United States, and in and to all divisions, reissues, continuations, continuations-in-part, substitutions, renewals, reexaminations, and extensions thereof including the full right to claim for any such application the benefits of the International Convention, the same to be held and enjoyed by Cryovac, Inc., its successors and assigns as fully and entirely as the same would have been held by me had this assignment and sale not been made.

And we do hereby authorize and request the Commissioner of Patents of the United States and the Patent Office officials in countries foreign to the United States to issue said Letters Patent to Cryovac, Inc., as the assigns of our entire right, title, and interest in, to, and under the same, and we hereby further authorize said Cryovac, Inc. to apply for Letters Patent in my name or in its own name, as it in its sole discretion sees fit, utilizing any benefits which may exist under any International Arrangement, in any country foreign to the United States.

And we do hereby agree for ourselves and for our heirs, executors, and administrators to execute any lawful document and to testify as to any material fact or thing which Cryovac, Inc., its successors and assigns may deem necessary in order to secure unto itself, its successors and assigns the full right, title, and interest in and to and the full enjoyment of said invention or any part therefor and the said Letters Patent or any of them, the same to be done without any further consideration.
