ASSIGNMENT OF PATENT RIGHTS


For valuable consideration, the receipt and sufficiency of which Assignor acknowledges, Assignor hereby sells, assigns, and transfers to Assignee, its successors, legal representatives and assigns, the entire right, title and interest in and to: the applications and/or patents as set forth in Appendix A ("Parent Patents"); all inventions disclosed in the Parent Patents ("Inventions"); any divisions and/or continuations of Parents Patents ("Child Patents") and any other application claiming priority from or the benefit of one or more of Parent Patents, including continuations-in-part ("Improvement Patents"), and patent applications from which Parent Patents claim priority and/or benefit ("Other patents") (e.g. provisional patent applications); where Parent Patents, Child Patents, Improvement Patents, and Other Patents, past, present, or future, will hereafter be referred to as "Assigned Patents", any reissues, reexaminations, or extensions of the Assigned Patents; the right to file foreign applications directly in the name of Assignee of Assigned Patents; the right to claim priority rights deriving from the Assigned Patents, and all rights of prior infringement with respect to the Assigned Patents (collectively "the Patent Rights").

Assignor warrants that it is the sole owner of the Patent Rights, and that the Patent Rights are unencumbered. Assignor also agrees to not sign any writing or do any act conflicting with this assignment, and, without further compensation, sign all documents and do such additional acts as Assignee deems necessary or desirable to: perfect Assignee's enjoyment of the Patent Rights; prepare, prosecute, issue and maintain the Assigned Patents; conduct proceedings regarding the Patent Rights, including any litigation or interference proceedings; or perfect or defend title to the Patent Rights. Assignor requests the Commissioner of Patents to issue any Patent of the United States that may be issued on the Invention(s) and/or Assigned Patents directly to Assignee.
