ASSIGNMENT

WHEREAS, I, Henry A. Hill, a citizen of the United States and residing at 340 S. Avenida de Palmas, Tucson, Arizona 85716, United States of America, am the Inventor of certain new and useful inventions and discoveries, for which I have made an application for a United States Patent entitled "APPARATUS AND METHOD FOR IN SITU AND EX SITU MEASUREMENTS OF OPTICAL SYSTEM FLARE" also identified as Attorney Docket Number 114096.157US2 ZI-79, the specification of which was filed with the United States Patent and Trademark Office on May 15, 2006, and has been assigned Serial Number 11/383,328.

2. Authorize ASSIGNEE to file patent applications in any or all countries on any or all of said inventions and discoveries in our names or in the name of ASSIGNEE or otherwise as ASSIGNEE may deem advisable, under International Conventions or otherwise;

3. Authorize and request the Commissioner of Patents and Trademarks of the United States of America and the empowered officials of all other governments throughout the world to issue or transfer

all said Letters Patent(s) to ASSIGNEE, as assignee of the entire right, title, and interest therein or otherwise as ASSIGNEE may direct;

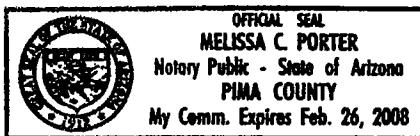
