ASSIGNMENT**Joint Inventorship**

WHEREAS, Young-Chul LEE; Dong-Gil KIM; and Sung-Jung KIM, hereinafter called the "Assignors", have invented a new and useful CASSETTE ASSEMBLY AND METHOD OF MANUFACTURING FLUORESCENT LAMPS USING THE CASSETTE ASSEMBLY, for a full description of which reference is here made to an application for Letters Patent of the United States executed by them on even date herewith; and

requested by the said Assignee to fully carry out the terms of this assignment. The Commissioner of Patents and Trademarks is hereby authorized and requested to issue Letters Patent to the said Assignee in accordance with the terms of this assignment.
