ROBERT L. BROAD, JR.

I, ROBERT L. BROAD, JR., a citizen of the United States of America, a resident of the County of Morgan, State of Alabama, being of sound and disposing mind and memory, do make, publish and declare this instrument as and for my Last Will and Testament, hereby revoking any and all other Wills and Codicils heretofore made by me.

ITEM I.

PAYMENT OF DEBTS/PROBATE OF WILL

I direct that all my debts, including the expenses of my last illness and funeral, shall be first paid out of my estate by my Executor, hereinafter named, as soon as possible after my death. I further direct that my Executor may probate my Last Will and Testament either in the county of my residence at the time of my death or in any county in the State of Alabama in which I may own property at the time of my death.

ITEM II.

DISPOSITION OF PERSONAL EFFECTS AND ESTATE

I give and devise all of my estate, real, personal or mixed of which I may die seized and possessed, or to which I may be entitled at the time of my death, or which I may have testamentary control, wheresoever and whatsoever it may be, including all lapsed legacies and devises, unto to my wife, MARY S. BROAD. I give and devise all of my wearing apparel, jewelry, books, pictures, household furniture and furnishings, both useful and ornamental, any automobile that I may own, and all other of my personal property, to my wife, MARY S. BROAD, absolutely, if she is living at the time of my death. In the event my said wife shall predecease me, I give and devise all of said objects of property, in equal shares, absolutely, to my children, SUSAN B. BROAD and SHERMAN A. BROAD. If either of my children should predecease me, then I give and devise said child's share of said property to his or her then living issue, per stirpes, if any, and if none, to my other child, per stirpes. In the event that my said wife and my said children should all predecease me, leaving no issue surviving, then this devise shall lapse, and the aforesaid property shall become a part of the residue of my estate. I hereby vest in my Executor, hereinafter named, full power and authority to determine

what objects of property are included in the foregoing description contained in this item of my Will, and, in the event my wife shall not be living, to make such division of said objects of property between my children as, in the opinion of my Executor, may be desirable, having due regard for the personal preferences of my said children.

ITEM III.

MISCELLANEOUS

- (a) It is my will and I direct that the invalidity of any gift or devise, or of any limitation over, or interest intended, as to any property or as to any beneficiary, shall not be considered materially to disturb the plan of distribution herein created or to affect the validity of any other gift or devise or limitation over, or interest in herein given or created.
- (b) I specifically authorize and empower my Executor regardless of whether or not it affects the interest of any beneficiary under this Will, or the amount of property directed to such beneficiary now or hereafter, to exercise any election granted by the Internal Revenue Code in effect at the time of my death which permits my Executor to take as deductions for federal income tax purposes any amounts which are also allowable for federal estate tax purposes, and my Executor shall incur no liability whatsoever to any beneficiary under this Will as the result of any elections so made, and no adjustment between principal and income shall be required as a result of such election.
- (c) Anything to the contrary not withstanding, in the event that any property or interest in property or life insurance passing under this Will, by operation of law or otherwise by reason of my death, shall be encumbered by mortgage or lien, or shall be pledged to secure any obligation (whether the property or interest in property so encumbered or pledged shall be owned by me jointly or individually), it is my intention that such indebtedness shall not be charged to or paid from my estate, but that the devisee, legatee, joint owner taking by survivorship, or beneficiary receiving such property or interest in property shall take it subject to all encumbrances existing at the time of my death.
- (d) it is my direction and intention that my Last Will and Testament be interpreted and administered by my Executor in accordance with the Internal Revenue Code of 1986, as amended. My Executor shall not be liable to any beneficiary herein for any action taken or not taken, election made or not made, or resulting federal income tax consequences upon the apportionment or distribution in kind or otherwise of any asset of my estate, where such Executor has exercised good faith and ordinary diligence in

the performance of its duties.

- (e) As to the net income which, by any of the provisions of this Will, may be payable to any of my lineal descendants, he or she shall have no right or power, either directly or indirectly, to anticipate, charge, mortgage, encumber, assign, hypothecate, sell or otherwise dispose of same, or any part thereof, until same shall have been actually paid to him or her by the Executor. Nor shall such income, nor the principal nor corpus of said estate, nor any part of, or interest in, either of them be liable for or to any extent subject to any debts, claims or obligations of any kind or nature whatsoever, or to any legal process in aid thereof, contracted or incurred by or for any such child or descendant, before or after my death.
- (f) I specifically authorize and empower my Executor to execute and file a joint income tax return with my wife for the year in which my death occurs and for any years prior thereto. I also authorize and empower my Executor to execute and file joint gift tax returns with my wife if any gift tax return is required of either of us for the year in which my death occurs or for any year prior thereto. I also specifically authorize and empower my Executor to pay any portion or all of any resulting income taxes and gift taxes. I grant full discretion to my Executor to acquiesce in. compromise, or litigate any demand made against m,y estate for federal or state income or estate taxes. My Executor shall incur no personal liability for any action taken by it in good faith in accordance with either of the forgoing authorizations.

ITEM IV.

SIMULTANEOUS DEATH

In the event my death and the death of my said wife shall occur simultaneously, or approximately so, under circumstances causing doubt as to which of us survived the other, or, in the event the death of my said wife shall occur within five (5) days after my death, then, any presumption created by the laws of the State of Alabama, or any other applicable jurisdiction notwithstanding, I direct that it be presumed that my said wife survived me.

ITEM V.

EXECUTORS

- (a) I hereby nominate and appoint my sister, BERYL FRENCH BROAD TIDWELL, as Executor of this, my Last Will and Testament.
 - (b) I direct that the Executor shall not be required to

give any bond or to file an inventory or appraisal of my estate or to make any accounting, report or final settlement in any court, though it shall make out and keep an inventory and shall exhibit the same to any party of interest at any reasonable time, provided, however, unless compelled by a court of competent jurisdiction, my Executor shall not be required to inventory any property passing to my wife, such as wearing apparel, jewelry, books, pictures, household furniture and furnishings. I hereby vest in said Executor full powers of management, control and disposition of my estate, and I direct that in the exercise of such powers my Executor shall be free from the control and supervision of the Probate Court, or any other court.

ITEM VI.

DEFINITIONS

As used in my Will, the terms "issue", "descendants" and "lineal descendants" are intended to include any persons heretofore or hereafter born or adopted by any descendant of mine, and my children, SUSAN B. BROAD and SHERMAN A. BROAD, but any person who is adopted on or after age twenty-one (21) years, and the issue of any such persons, are intended to be excluded from this term. As used in my Will, the terms "child" and "children" are intended to refer to SUSAN B. BROAD and SHERMAN A. BROAD. Where the context so permits, the term "Executor" and words of reference to my Executor, shall mean any person or entity serving in that capacity.

IN WITNESS WHEREOF, I, the undersigned, ROBERT L. BROAD, JR., have hereunto set my hand and seal on this 22 day of June, 1999.




