

and entirely as the same would have been held and enjoyed by the assignors, had this sale and assignment not been made.



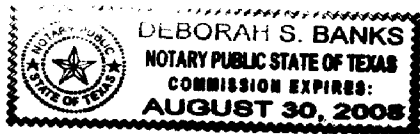
