ASSIGNMENT

WHEREAS, I, **CHI GON CHEN**, ASSIGNOR, residing at Sha Xi Industrial, Jiang Gao Town, Bai Yun Interval, Guang Zhou, China, and citizen of the People's Republic of China, am the sole inventor of the invention entitled "**Solar Powered Insect Exterminator**," a drawing of which is attached hereto as Exhibit "A" and incorporated by reference as if fully set forth herein; and

Convention for the Protection of Industrial Property, or any other international agreement or the domestic laws of the country in which any such applications are filed, as may be applicable; and all forms of industrial property protection, including, without limitation, patents, utility models, and design which may be granted for said invention in any country or countries foreign to the United States, and all extensions, renewals, and reissues thereof;


I FURTHER HEREBY authorize and request the Commissioner for Patents of the United States, and any official of any country or countries foreign to the United States, whose duty it is to issue patents or other evidence or forms of industrial property protection on applications as aforesaid, to issue the same to the said ASSIGNEE, its successors, legal representatives, and assigns, in accordance with the terms of this instrument;

I FURTHER HEREBY covenant that I have full right to convey my entire interest herein assigned and that I have not executed, and will not execute, any agreement in conflict herewith;

I FURTHER HEREBY convent and agree that I will communicate to the said ASSIGNEE, its successors, legal representatives, and assigns, any facts known to me respecting said invention, and testify in any legal proceeding, sign all lawful papers, execute all divisions, continuing and reissue applications, make all rightful oaths, and generally do everything possible to aid the said ASSIGNEE, its successors, legal representatives, and assigns, to obtain and enforce proper patent protection for said invention in all countries.
