## ASSIGNMENT

WHEREAS, WE, **FRED RICHARD SCHOLER**, a citizen of the United States of America, residing at 47 Brooktree Road, East Windsor, New Jersey 08520, **HSING-HUI YU**, a citizen of the United States of America, residing at 691-1/2, Chestnut Street, Kearny, New Jersey 07032; and **WAYNE A. MERRIFIELD**, a citizen of the United States of America, residing at 51 Winding Brook Road, Hamburg, New Jersey 07419, hereinafter referred to as ASSIGNORS, have invented certain new and useful improvements in **COLORLESS PRIMER COMPOSITION AND METHOD** for which we filed an application for Letters Patents with the United States Patent and Trademark Office on August 2, 2006, as Patent Application No. 11/498,636.

AND WE HEREBY grant to Lawrence Rosenthal, Steven B. Pokotilow, Matthew W. Siegal, David L. Schaeffer and Ian G. DiBernardo, attorneys with the firm of Stroock & Stroock & Lavan LLP, the right and full power of attorney to enter all further identifying information of the improvements and the application as may be deemed necessary or desirable for the recordation or perfection of this ASSIGNMENT.

AND WE HEREBY covenant that we have full right to convey the entire interest herein assigned, and that we have not executed, and will not execute, any agreement in conflict herewith.

AND WE HEREBY further covenant and agree that we will communicate to the ASSIGNEE, its successors, legal representatives and assigns, any facts known to us respecting the improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and generally do everything possible to aid the ASSIGNEE, its successors, legal representatives and assigns, to obtain and enforce proper patent protection for the improvements in all countries.


