AND ASSIGNOR HEREBY authorizes and requests the Commissioner of Patents, or the equivalent thereof, to issue the same to the said ASSIGNEE, its successors, legal representatives and assigns, in accordance with the terms of this instrument.





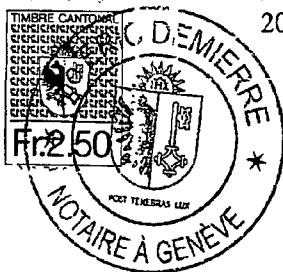
