Accordingly, I have executed this assignment this 16th day of NOVEMBER, 2006.



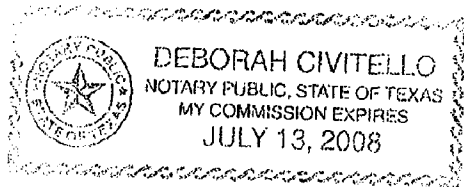
