ASSIGNMENT AND AGREEMENT

WHEREAS, William Webb of 113 Shorebird Circle, Redwood City, CA 94065-1537, Alan C. Urban of 4634 Fallstone Court, San Jose, CA 95124, Richard Gioscia of 1610 Nantucket Circle, Apt. 315, Santa Clara, CA 95054, Lawrence Lam of 6313 Tucker Drive, San Jose, CA 95129, and David Northway of 1441 Oakhurst Avenue, San Carlos, CA 94070, (hereinafter referred to singly and collectively as "ASSIGNOR") have invented a certain invention entitled **MINIATURE KEYBOARD FOR A HAND HELD COMPUTER** (Atty. ASSIGNOR HEREBY AGREES (a) to communicate to ASSIGNEE, its successors and assigns, or their representatives or agents, all facts and information known or available to ASSIGNOR respecting said invention or inventions, improvements, and modifications including evidence for interference, reexamination, reissue, opposition, revocation, extension, or infringement purposes or other legal, judicial, or administrative proceedings, whenever requested by ASSIGNEE; (b) to testify in person or by affidavit as required by ASSIGNEE, its successors and assigns, in any such proceeding in the United States or a country foreign thereto; (c) to execute and deliver, upon request by ASSIGNEE, all lawful papers including, but not limited to, original, divisional, continuation, and reissue applications, renewals, assignments, powers of attorney, oaths, affidavits, declarations, depositions; and (d) to provide all reasonable assistance to ASSIGNEE, its successors and assigns, in obtaining and enforcing proper title in and


protection for said invention or inventions, improvements, and modifications under the intellectual property laws of the United States and countries foreign thereto.


