ASSIGNMENT AND AGREEMENT

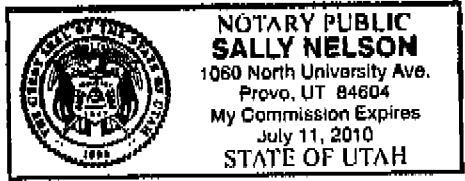
