BELL ATLANTIC NETWORK SERVICES, INC.**



RESOLVED, that the Restated Certificate of Incorporation of the Corporation be amended by changing Article 1 thereof so that, as amended, the Article shall be and read as follows:

- "1. The name of the Corporation is Verizon Services Corp.
The date of filing its original Certificate of Incorporation
with the Secretary of State was October 14, 1983."

This Certificate of Amendment of the Restated Certificate of Incorporation shall be effective on August 1, 2000.
