Declaration

Frankfurt, March 7, 2005

1. Hoechst Research & Technology Deutschland GmbH & Co. KG (registered number HRA 28517) was a limited partnership established by Hoechst Aktiengesellschaft as its sole limited partner and Hoechst Research & Technology Deutschland Verwaltungs GmbH (then with its registered office in Frankfurt am Main, registered number HRB 39459) as its sole general partner.
2. On 29 May 1998 Hoechst Research & Technology Deutschland Verwaltungs GmbH changed its name to Aventis Research & Technologies Verwaltungs GmbH (registered number HRB 39459) and on 4 November 1998 Hoechst Research & Technology Deutschland GmbH & Co. KG changed its name to Aventis Research & Technologies GmbH & Co KG (registered number HRA 28517).
3. With legal effect as of 31 May 2003 and registered with the commercial register on 18 June 2003 Hoechst Aktiengesellschaft, as sole limited partner in Aventis Research & Technologies GmbH & Co KG withdrew from the limited partnership leading to the dissolution of the partnership Aventis Research & Technologies GmbH & Co KG. All of its assets and obligations were transferred by operation of law to the sole general partner Aventis Research & Technologies Verwaltungs GmbH (registered number HRB 39459), which became the legal successor of the limited partnership.
4. With effect as of registration on 29 August 2003, Aventis Research & Technologies Verwaltungs GmbH (registered number HRB 39459) was merged into Aventis Pharma Deutschland GmbH as the transferee company with Aventis Pharma Deutschland GmbH becoming the legal successor to Aventis Research & Technologies Verwaltungs GmbH (registered number HRB 39459) and due to the previous transfer of assets and obligations accordingly the final legal successor to Aventis Research & Technologies GmbH & Co KG (registered number HRA 28517) and to all of the assets and obligations of Aventis Research & Technologies GmbH & Co KG (registered number HRA 28517) and Aventis Pharma Deutschland GmbH assuming by operation of law the obligations of Aventis Research & Technologies GmbH & Co KG (registered number HRA 28517) in respect of the Intellectual Property.

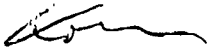

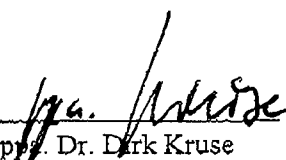

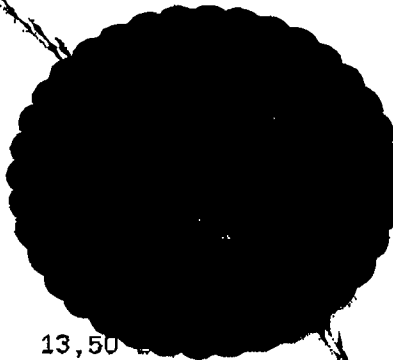
