ASSIGNMENT

WHEREAS, I, the below named inventor, has invented a certain new and useful invention disclosed in U.S. Patent Application Serial No. 10/430,747 filed on May 6, 2003 entitled "Line Retrieval System and Method", which claims priority to U.S. Provisional Patent Application Serial No. 60/381,119 filed on May 16, 2002.

I also hereby sell and assign to said ASSIGNEE, its successors, assigns and legal representatives the full and exclusive right, title and interest to the inventions disclosed in said application throughout the world, including the right to file applications and obtain patents, utility models, industrial models and designs for said inventions in its own name, all rights to publish cautionary notices reserving its ownership of said invention, all rights to register said invention in appropriate registries throughout the world, and all rights of priority under the terms of the International Convention for the Protection of Industrial Property and other applicable conventions and treaties.

I will execute any and all powers of attorney, applications, assignments, declarations, affidavits, and any other papers in connection therewith necessary to perfect and fully vest the forgoing rights, title and interest in ASSIGNEE, its successors, assigns and legal representatives.

I will communicate to ASSIGNEE, or to its successors, assigns and legal representatives, any facts known to me respecting the inventions and any improvements; and, at the expense of ASSIGNEE, will testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, continuation-in-part, reissue and substitute applications, and make all lawful oaths, and generally do everything reasonably necessary to vest title in ASSIGNEE and to aid ASSIGNEE, its successors, assigns and legal representatives in obtaining and enforcing protection for said inventions in all countries throughout the world.

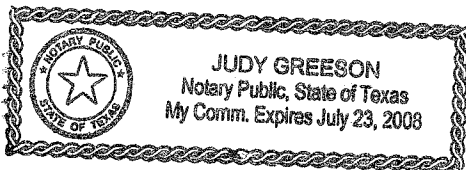
