

WE hereby request the Honorable Commissioner of Patent and Trademarks to issue said Letters Patent to said Assignee.

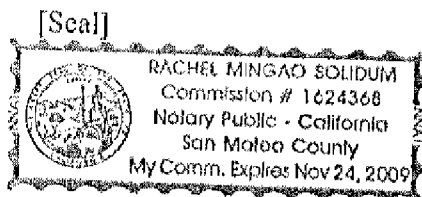
