## ASSIGNMENT

WHEREAS, WE, PAOLO BAIOCCHI, a citizen of Italy, residing at Strada Farini 43, I-43100 Parma; Italy; GRAZIANO MARUSI, a citizen of Italy, residing at Strada Eia 26/1, Eia, I-43100, Parma, Italy; and FEDERICO MENTA, a citizen of Italy, residing at Via Verdi 9, I-43100 Parma, Italy; respectively, hereinafter referred to as ASSIGNORS, have invented certain new and useful improvements in POLARIZED OPTICAL ELEMENTS HAVING DIFFERENTIATED TRANSMITTANCE PROPERTIES FOR USE IN EYE-PROTECTING DEVICES, which was filed with the United States Patent and Trademark Office on June 8, 2006, and which has been accorded Application Serial No. 11/450,797;

WHEREAS, INTERCAST EUROPE S.P.A., an Italian Corporation, having offices at 10/A, Via G. Natta – AREA SPIP, 43100 Parma, Italy, hereinafter referred to as ASSIGNEE, is desirous of obtaining the entire right, title and interest in, to and under the improvements and the application;

NOW, THEREFORE, in consideration of the sum of One Dollar (\$1.00) to us in hand paid, and other good and valuable consideration, the receipt of which is hereby acknowledged, we, the ASSIGNORS, have sold, assigned, transferred and set over, and by these presents do hereby sell, assign, transfer and set over, unto the ASSIGNEE, its successors, legal representatives and assigns, the entire right, title and interest in, to and under the improvements, and the application and all divisions, renewals and continuations thereof, and all Letters Patent of the United States which may be granted thereon and all reissues and extensions thereof, and all applications for Letters Patent which may hereafter be filed for the improvements in any country or countries foreign to the United States, and all Letters Patent which may be granted for the improvements in any country or countries foreign to the United States and all extensions, renewals and reissues thereof; and we hereby authorize and request the Commissioner of Patents of the United States, and any Official of any country or countries foreign to the United States whose duty it is to issue patents on applications as aforesaid, to issue all Letters Patent for the improvements to the ASSIGNEE, its successors, legal representatives and assigns, in accordance with the terms of this instrument.

AND WE HEREBY grant to Lawrence Rosenthal, Steven B. Pokotilow, Matthew W. Siegal, David L. Schaeffer and Ian G. DiBernardo, attorneys with the firm of Stroock & Stroock & Lavan LLP, the right and full power of attorney to enter all further identifying information of the improvements and the application as may be deemed necessary or desirable for the recordation or perfection of this ASSIGNMENT.


AND WE HEREBY covenant that we have full right to convey the entire interest herein assigned, and that we have not executed, and will not execute, any agreement in conflict herewith.
