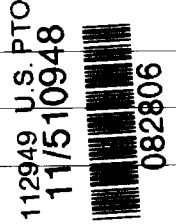

ASSIGNMENT

WHEREAS, WE, Mirko Essling, a citizen of Germany, residing at Wackenmuhlstrasse 16, Kaiserslautern, Germany 67655; Michael Kasper, a citizen of Germany, residing at Konrad-Adenauer-Strasse 124, Kaiserslautern, Germany 67663; and, Dr. Klaus-Werner Joerg, a citizen of Germany, residing at Wiesenstrasse 7, Schopp, Germany 67707; (hereinafter referred to as "ASSIGNORS"), have invented a MEASURING DEVICE AND MEASURING METHOD FOR DETERMINING DISTANCE AND/OR POSITION, for which we have executed an application for Letters Patent of the United States, filed of even date herewith, and

ASSIGNORS HEREBY authorize and request the Commissioner of Patents and Trademarks of the United States, and any Official of any country or countries foreign to the United States, whose duty it is to issue patents or other evidence or forms of industrial property protection on applications as aforesaid, to issue the same to the said ASSIGNEE, its successors, legal representatives and assigns, in accordance with the terms of this instrument.

ASSIGNORS HEREBY grant the firm of Frederick H. Gribbell, LLC the power to insert in this Assignment any further identification or information which may be necessary or desirable in order to comply with the rules of the United States Patent and Trademark Office for recordation of this document.


