**AND I HEREBY** warrant and covenant that I have not executed and will not execute any instrument or assignment in conflict herewith;



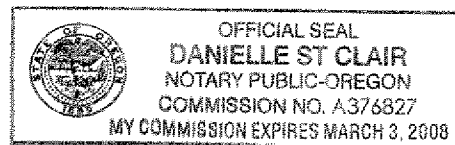
