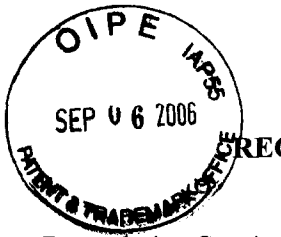



AND WHEREAS the parties wish that the Assignee own the entire worldwide right, title and interest in and to the Design, including the Applications;







