NOW, THEREFORE, in exchange for the sum of one dollar (\$1.00) and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby assign to Assignee, all right, title and interest in and to the Patents, including the right to bring an action for past infringement, and any divisions, reissues, continuations, continuations-in-part, renewals and extensions of such Patents to be held and enjoyed by Assignee for its own use and benefit and for the use and benefit of its successors, assigns or other legal representatives to the end of the term for which such Patents are granted or reissued as fully and entirely as the same would have been held and enjoyed by Assignor if this assignment and sale had not been made.
