ASSIGNMENT

WHEREAS, Taro Iwamoto, hereinafter called the "Assignor", has made the invention described in the United States patent application entitled DIGITAL VIDEO DISC PLAYER, for a full description of which reference is here made to an application for Letters Patent of the United States filed on June 20, 2006 and assigned Application Serial No. 29/261,781;

patents; and in the prosecution of any interference which may arise involving said invention, or any such patent application or patent; and that the Assignor will execute and deliver to the Assignee any and all additional papers which may be requested by the Assignee to carry out the terms of this Assignment.

The Commissioner of Patents and Trademarks is hereby authorized and requested to issue patents to the Assignee in accordance with the terms of this Assignment.
