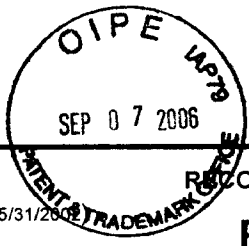


ASSIGNMENT


HEADREST ASSEMBLY FOR A MASSAGE DEVICE WITH TIMED SUPPORT ARMS
