Respectively, have made new and useful improvements in **Method and Apparatus for Accommodating Primary Content Audio and Secondary Content Remaining Audio Capability in the Digital Audio Production Process**, for which an application for Letters Patent was filed on December 10, 2002, and has been assigned Application Number 10/314,998; and
