**SECURITY AGREEMENT**

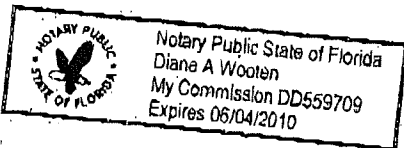
