AND we hereby consent that a copy of this assignment shall be deemed a full and formal equivalent of an assignment, consent to file or like document which may be required in any country or region for any purpose and more particularly in proof of the right of the said Assignee or nominees to claim the aforesaid benefit of the right of priority by the International Convention for the Protection of Industrial Property, as amended, or by any convention which may henceforth be substituted for it.

AND we hereby covenant that we have the full right to convey the entire right, title, and interest herein assigned and that we have not executed and will not execute an agreement in conflict herewith.
