HEREBY AGREE that I, my heirs, successors, assigns or other legal representatives will at any time upon the request and at the expense of said ASSIGNEE, its successors, assigns, or other legal representatives, without undue delay, execute and deliver any and all papers and do all lawful acts that may be necessary or desirable to perfect the title to said inventions, said applications, and any patent or patents that may be obtained therefore; and



HEREBY REPRESENT and warrant that we have the full right to convey the entire interest of said inventions and said applications herein assigned and have not granted any rights inconsistent with the rights granted herein.
