AND, for the same consideration, I agree to sign all lawful papers, execute all non-provisional, division, continuation, reissue, and other applications, make all assignments and rightful oaths, and generally do everything possible to aid the **Federal Reserve Bank of Atlanta**, its successors, assigns, and nominees to obtain and enforce proper protection for all said inventions and improvements in all countries throughout the world.
