ASSIGNMENT OF PATENT AND TRADEMARK RIGHTS
UNITED STATES

This Assignment of Patent and Trademark Rights (this "Assignment") is made and entered into as of the 9th day of March, 2006, by and between **Tape Craft Corporation**, an Alabama corporation having an office at 200 Tapecraft Drive, Oxford, Alabama 36201 ("TCC") and **YKK Corporation of America**, a New York corporation having an office at 1850 Parkway Place, Suite 300, Marietta, Georgia 30067 ("YKK").

BACKGROUND

WHEREAS, on November 9, 2004, TCC acquired from Textiles2, Inc. ("T2") all rights, title, and interest in and to Patent and Trademark Rights (as defined by that certain Intellectual Property Purchase Agreement (the "Purchase Agreement") incorporated herein by reference;

WHEREAS, TCC desires to transfer all Patent and Trademark Rights acquired under the Purchase Agreement to YKK (such Patent and Trademark Rights as identified on Exhibit "A" attached hereto and incorporated herein by reference);

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1 1. ASSIGNMENT

0 TCC hereby conveys and assigns to YKK all of TCC's right, title, and interest in the Patent and Trademark Rights.

0 1.2 TCC hereby assigns and delegates to YKK (and YKK accepts and agrees to perform) all of TCC's rights and obligations under the Purchase Agreement.

1 1.3 TCC and YKK each hereby agree to execute such documents and to take such other actions as shall be necessary or appropriate to effectuate the assignments set forth in this Section 1.

1 2. MISCELLANEOUS. If any provision of this Assignment shall be adjudicated by any court of competent jurisdiction to be unenforceable or invalid, that provision shall be limited or eliminated to the minimum extent necessary to continue to effect the intent of the parties, and this Assignment shall otherwise remain in full force and effect. This Assignment shall be governed by the laws of the State of Georgia, excluding conflicts of law principles. This Assignment is the complete and exclusive statement of the mutual understanding of the parties. This Assignment may be executed in a number of counterparts, each of which is deemed to be an original.

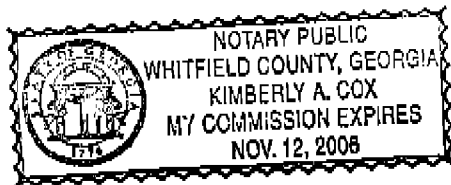
