NOW, THEREFORE, for good and valuable consideration acknowledged by SLA to have been received in full from Sharp, SLA does hereby sell, assign, transfer, convey, and quitclaim unto Sharp all of SLA's right, title and interest in and to said patent and said invention.

The terms and covenants of this Assignment shall inure to the benefit of Sharp, its successors, assigns and other legal representatives, and shall be binding upon SLA, its successors, assigns and other legal representatives.
