## NUNC PRO TUNC ASSIGNMENT OF PATENT APPLICATIONS



The effective date of this nunc pro tunc assignment is September 5, 1997.

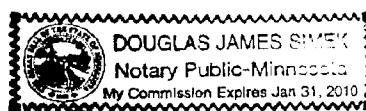
