

Assignors hereby authorize and request the Patent and Trademark Office officials in the United States and its territorial possessions and in any and all foreign countries to issue and all of said Letters Patent, when granted, to said Assignee as Assignors' entire right, title and interest in and to the same, for the sole use and behalf of said Assignee, its successors and assigns, to the full end of the term for which said Letters Patent may be granted, as fully and as entirely as the same would have been held by Assignors had this Assignment not been made.


