### Terms

1. Consideration. In exchange for HOOVER delivering any and all shares of stock in AMERCO owned by him and his family totaling 4,000 shares of common stock endorsed in blank, HOOVER's resignation as an officer and director and U.S. \$60,000.00 to STAHL, who will upon such receipt thereof does indemnify, save, and hold harmless HOOVER from any and all liability arising from HOOVER's personal written guarantee of any debts of AMERCO.

- d. All rights in trademarks and service marks;
- e. Manufacturing rights east of the Mississippi River;
- f. Sales right anywhere in the world; and
- g. Supplier access to all AmeraCover suppliers for the securing and paying of all production materials, machinery and equipment, supplies, and professional services.


**2. Miscellaneous.**


e. This Agreement shall be binding on the heirs, successors, and assigns of the parties hereto.


