ENVIRONMENT SOLUTION AS, its successors and assigns, the title herein conveyed or intended so to be, and to enable such title to be recorded in the United States.

AND WE FURTHER covenant and agree, in consideration of the premises, that we or our executors and administrators, will at any time upon request communicate to the said ENVIRONMENT SOLUTION AS, its successors and assigns, any facts relating to the said invention and improvements and the history thereof, known to us or to our executors and administrators, and that we will testify as to the same in any interference or other litigation when requested so to do by the said ENVIRONMENT SOLUTION AS, it being understood that ENVIRONMENT SOLUTION AS will compensate us for our expenses reasonably incurred in complying with its requests.
