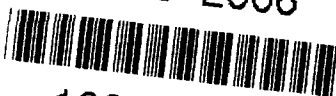


### Assignment of Application and Patent






