Assignor also hereby authorizes the respective patent office or governmental agency in each jurisdiction to issue any and all patents or certificates of invention, which may be granted upon any of the Patent Rights in the name of Assignee, as the assignee to the entire interest therein. Notwithstanding the foregoing, Assignee will be responsible for paying any governmental fees for recording the assignment of the Patent Rights.

The terms and conditions of this Assignment shall inure to the benefit of Assignee, its successors, assigns and other legal representatives, and shall be binding upon Assignor, its successor, assigns and other legal representatives.
