PATENT ASSIGNMENT

WHEREAS, GALILEO PHARMACEUTICALS, INC., formerly Galileo Laboratories, Inc., a California corporation, (hereinafter referred to as "Assignor") with principal offices located at 5301 Patrick Henry Drive, Santa Clara, CA 95054 owns right, title and interest in and to certain patents and patent applications identified in Table 1 below ("Patents"); and incorporated herein by reference; and

- (b) the benefit of all priority rights of the Patents;
- (c) the right to seek and obtain registrations in other countries in respect of the Patents or any other patent included in the Patent Rights;
- (d) the right to sue for and obtain injunctive relief, damages and all other relief in respect of any infringement or misuse (whether past present or future) of the Patents or of the rights conferred by publication of the application for the same or of any other of the Patent Rights; and
- (e) any and all choses in action and any and all claims and demands, both at law and in equity, that said Assignor has or may have for damages or profits accrued or to accrue on account of the infringement of any of said Patents, the same to be held and enjoyed by said Assignee, its successors and assigns, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment and sale had not been made.

The Assignor agrees to execute any further documents and do all things which the Assignee may require in order to vest or confirm the vesting in the Assignee (or the Assignee's successors in title or nominees as the case may be) of the Patents and all other Patent Rights in all relevant jurisdictions and all other property rights title and interests intended to be assigned transferred or granted to the Assignee hereunder and to give the Assignee the full benefit of this Assignment including doing all acts which may be necessary or desirable to record the Patents in the name of the Assignee in all relevant jurisdictions. The Assignor hereby authorizes the Assignee and the Assignee's agents to sign all such forms on behalf of the Assignor as the Assignee considers appropriate in order to record the Patents and any other Patent Rights in the name of the Assignee. Assignee also agrees to transfer to Assignor all file histories for the Patents that are in Assignee's or Assignee's agents' possession.

This Assignment shall be governed by and construed and take effect in accordance with the law of the United States.

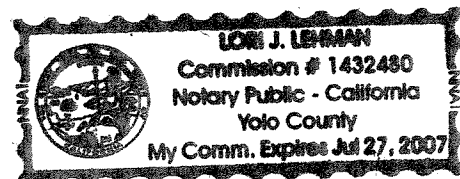
