
## ASSIGNMENT

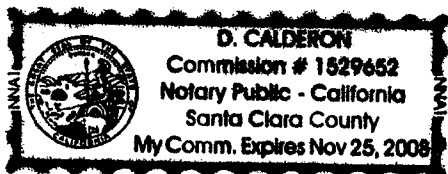
