## **ASSIGNMENT OF PATENT RIGHTS**

**WHEREAS**, on or about June 15, 2005, by unanimous written consent of the Board of Directors of Assignor, and as subsequently adopted by the Shareholders of Assignor, a Plan of Complete Liquidation and Dissolution (hereinafter the "Plan") was duly authorized and approved;

**WHEREAS**, the Plan provides for the assignment and transfer of the Patents by Assignor to CITICORP BANKING CORPORATION, a corporation organized under the laws of the State of Delaware, having a principal place of business at One Penns Way, New Castle, Delaware 19720 (hereinafter the "Assignee");


**WHEREAS**, Assignee desires to acquire said Patents and all divisionals, continuations, continuations-in-part and reissue patents and applications therefor and any patents issuing therefrom;

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor, by its duly authorized representative, does hereby assign, convey and transfer unto Assignee, its successors and assigns, the entire right, title and interest in, to and under said Patents in the United States, its territorial possessions and in all foreign countries, including all divisionals, continuations, continuations-in-part and reissue patents and applications therefor and any patents issuing therefrom, together with the right to sue for and be entitled to any damages for infringement of said Patents, and patents issuing therefrom; and further authorize and request the Commissioner of Patents of the United States and any official of any foreign country whose duty it is to issue patents or legal equivalents thereto, to record said assignments and issue all Patents, and patents issuing therefrom, to Assignee, its lawful successors and assigns.

This Assignment of Patent Rights may be executed in two or more counterparts, each of which shall be deemed an original, but all of which together shall constitute but one and the same agreement.
