ASSIGNMENT

WHEREAS, I, Mikael Arvidsson, citizen of Sweden, resident of the City of Jönköping, Country of Sweden, respectively, whose post office address is Bäckalyckevägen 36 BV, SE-553 13, Jönköping, Sweden, has invented certain improvements in PLAYGROUND EQUIPMENT DEVICE for which I am about to make, and have this day executed, application for Letters Patent of the United States, identified as Attorney's Docket No. RAAN 9751US.

AND I DO HEREBY authorize and request the Commissioner of Patents and Trademarks to issue that said Letters Patent, when granted, to the said HAGS ANEBY AB, a corporation, its successors and assigns, as assignees of the entire right, title and interest in and to said improvements, for the sole use and behoof of said HAGS ANEBY AB, a corporation, and for its successors and assigns, to the full ends of the terms for which Letters Patent may be granted.

AND I further grant to HAGS ANEBY AB, a corporation, its successors and assigns, the right to claim for any application for patent for said improvements the full benefit of any international agreement between the United States and any foreign country or countries.
