ASSIGNOR hereby requests that said Letters Patent by issued in accordance with this Assignment.

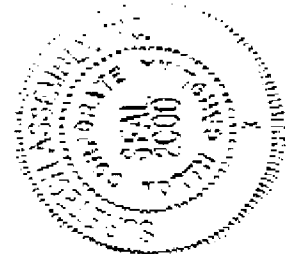
